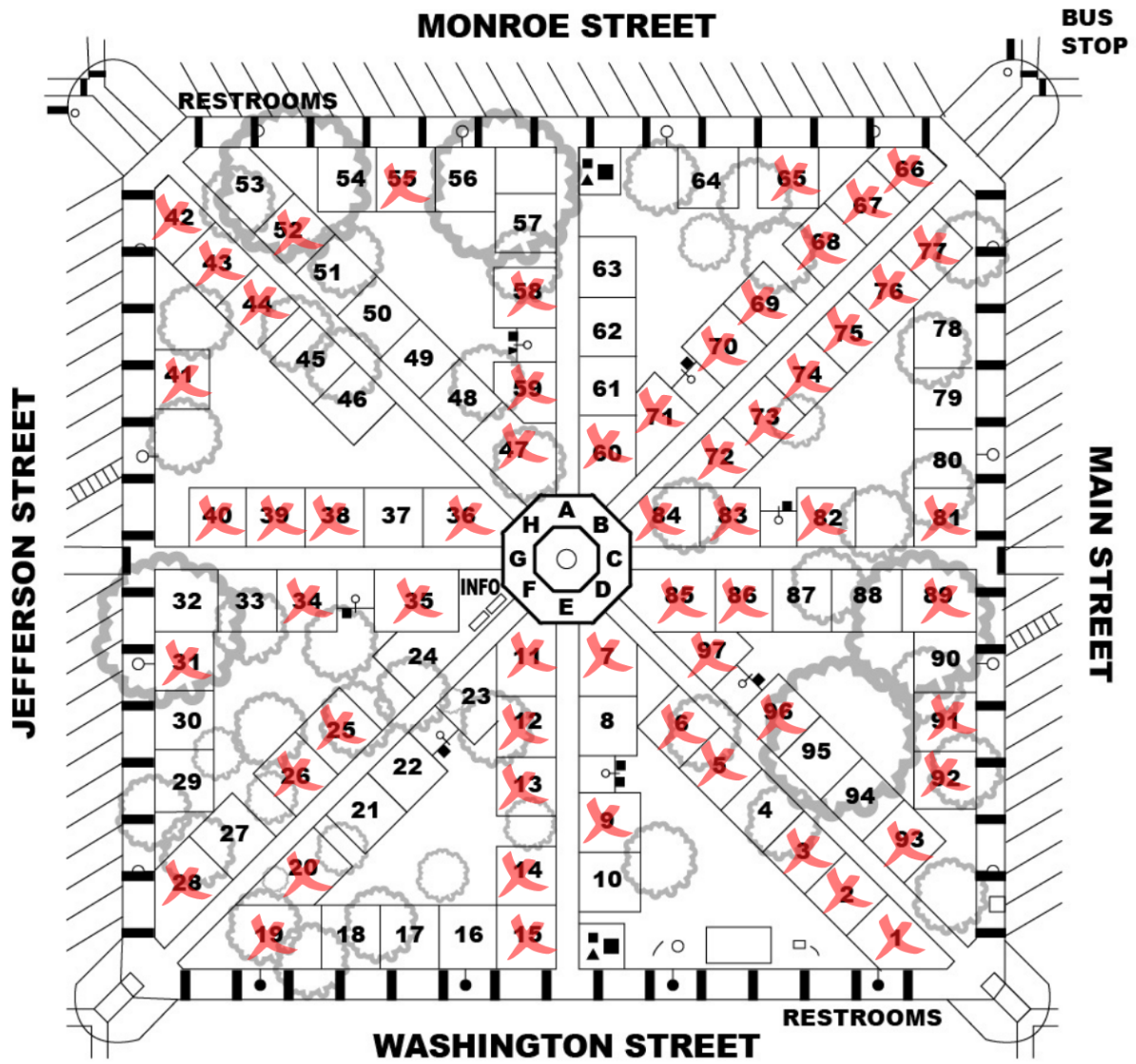

The committee has the authority to deny any application submitted within reason of our Vendor Policies and Procedures or due to lack of paperwork, failure to pay or because the items are not approved for the show. Fees are as follows: **\$275.00 for each spot in Central Park.**

A **NON-REFUNDABLE DEPOSIT of \$100.00** is due with this Vendor Application Form to secure a specified space. The remaining balance is due by **June 1st, 2021**. If your space is not paid for, IN FULL, by June 1st, 2021, it MAY be opened to vendors on the waiting list. In the event of cancelation 60, or more, days prior to Crafts in the Park, half of your payment (excluding deposit) will be refunded. In the event of cancelation 59, or less, days prior to Crafts in the Park, no refund will be granted. There is a \$25.00 fee for any returned (insufficient funds) checks.
